Our mission is to ensure a sustainable financial base for the effective management of the Bahamas National Protected Areas System and for conservation activities that protect the future and productivity of our national resources.

Local Projects

The BPAF has financed 21 projects in areas related to beach, mangrove and coral reef restoration; building climate resilience; energy resilience through solar installation and supporting projects that restore ecosystem health and resilience at local sites.
