Local Projects

Fondo MARENA has financed 12 projects in areas related to community governance in the management of resources; the conservation, protection and increased public awareness of the Bayahibe Rose (Dominican Republic's national flower); the design and construction of the Marine Mammal Sanctuary Estero Hondo; as well as other environmental education and awareness initiatives.
