To provide funding to support the conservation of biodiversity of Saint Vincent and the Grenadines.

Local Projects

The SVGCF has financed 15 projects in areas related to beach and coral reef restoration; farmland soil regeneration using vetiver systems technology; biodiversity conservation education; and assessment of marine and coastal environment following the La Soufriere Volcanic Eruption.
